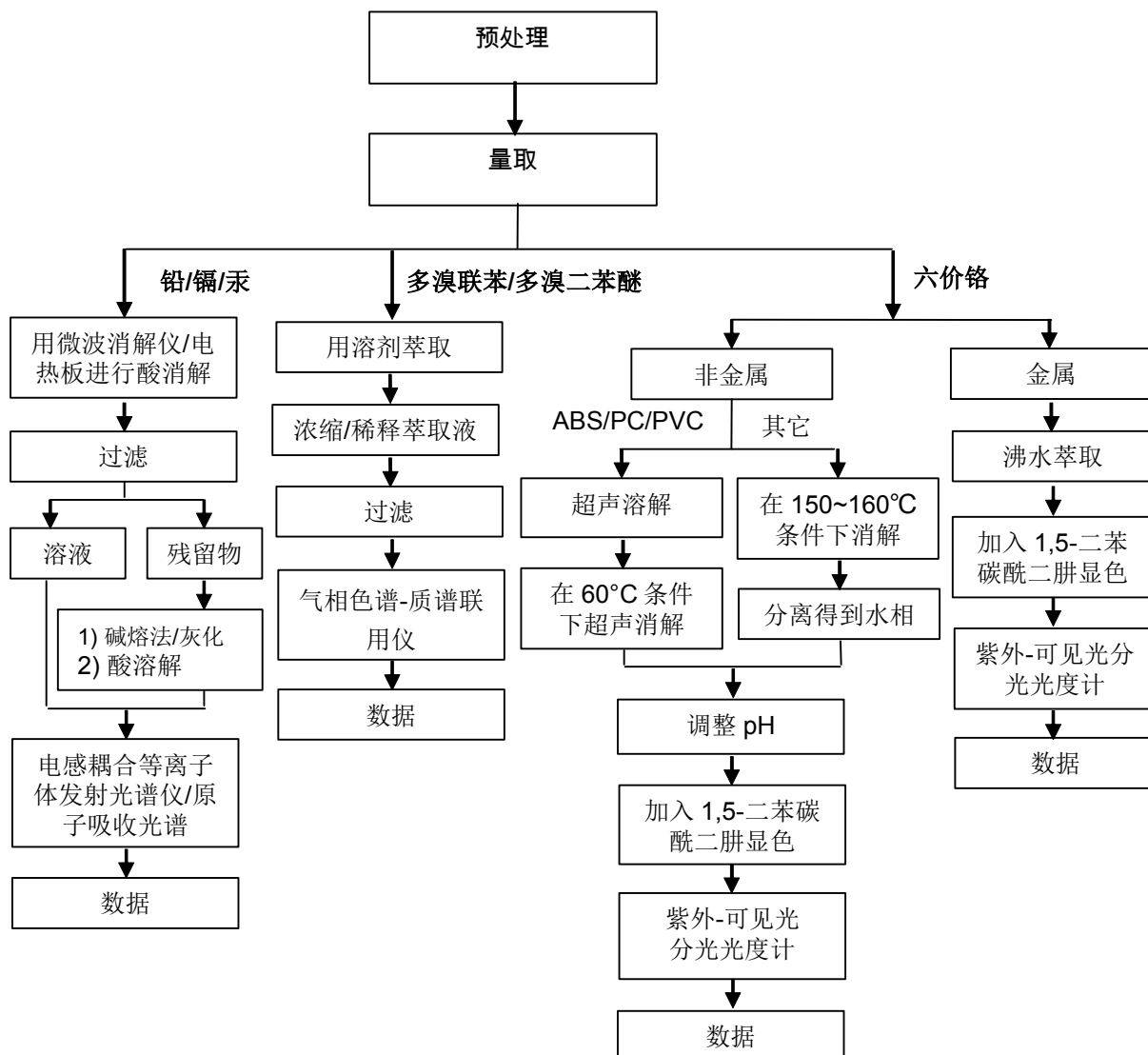

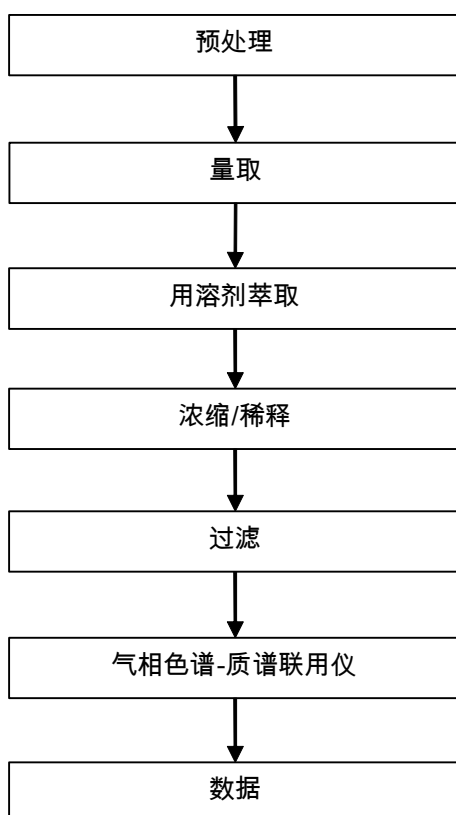
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs 测试流程图
